Chairman's Letter

Dear fellow shareholders

On behalf of the Board of Thorney Opportunities Ltd, I am pleased to present our Annual Report for the year ended 30 June 2026.



The 2026 financial year was characterised by a combination of strong equity market performance and elevated uncertainty. Global share markets generally traded near record highs, supported by resilient economic growth, ongoing technological innovation and substantial investment associated with artificial intelligence. At the same time, investors continued to contend with a range of geopolitical challenges, including trade tensions, tariff-related uncertainties and ongoing international conflicts that periodically affected sentiment and capital flows.

Inflationary pressures, while moderating in some regions, remained an important consideration for policymakers. Central banks maintained a cautious approach to monetary policy, balancing inflation objectives against the risk of slowing economic activity. Interest rates therefore remained a key driver of valuation outcomes across asset classes throughout the year.

Against this backdrop, artificial intelligence continued to dominate investment discussions. Significant global capital expenditure directed toward AI infrastructure, applications and ecosystems supported market leadership amongst technology-related businesses and reinforced the importance of innovation as a driver of long-term value creation.

For Thorney Opportunities Ltd (TOP), the year was one of active portfolio management and disciplined capital allocation. While broader markets achieved strong returns, opportunities remained highly selective. Our investment approach continued to focus on identifying undervalued companies where we believe operational improvement, strategic change or market recognition can unlock meaningful shareholder value over time.

TOP's net tangible assets finished the year ended 30 June 2026 slightly down at 89.3 cents per share versus the prior year. The Company's strongest portfolio positions in FY2026 were:

- **Southern Cross Electrical Engineering Limited;**
- **Macmahon Holdings Limited;**
- **QuickFee Limited;**
- **Service Stream Limited;** and
- **Zip Co Limited.**

These investments benefited from a combination of improved operating performance, favourable industry conditions, generally stronger dividends and stronger market recognition of underlying value.

Notwithstanding these successes, several investments detracted from performance during the year:

- **AMA Group Limited;**
- **Austin Engineering Limited;** and
- **20 Cashews Pty Ltd.**

While the performance of these positions was disappointing, periods of underperformance are an inherent part of long-term investing. We continue to assess each investment rigorously and remain focused on ensuring capital is allocated to opportunities that offer the most compelling risk-adjusted returns. We continue to see the potential value proposition in these investments as compelling.

During the year, we initiated new investments in **SPC Global Holdings Ltd** and **Acrow Limited** and increased our exposure to **Zip Co Limited** and **AMA Group Limited**, reflecting our conviction in the Company's long-term investment philosophy. These investments demonstrate our commitment to selectively deploying capital where we identify attractive long-term value creation opportunities.

A continuing frustration for the Board remains the persistent discount between the Company's share price and its underlying net tangible assets. While discounts to NTA are not unique to TOP and have become more pronounced across parts of the listed investment company sector, we recognise the

impact this has on shareholder outcomes. The Board and management team remain focused on initiatives designed to enhance shareholder value and improve market recognition of the quality of the Company's assets and investment strategy.

Capital management remained a priority throughout the year and, in that regard, TOP continued to be active with its on-market share buyback. It is the Board's view that acquiring shares under this program represents an efficient and value-enhancing use of capital for continuing shareholders.

The Board remains committed to delivering returns to shareholders through both capital growth and income. Reflecting the strength of the Company's balance sheet and its capacity to generate sustainable shareholder returns, TOP declared a final fully franked dividend of 1.65 cents per share, an increase over the final dividend in the prior period of around 6.5%. The total dividends declared in respect of FY2026 were 2.75 cents per share, an increase of 3.8% over FY2025.

Looking ahead, we expect market conditions to remain influenced by the interaction of inflation trends, monetary policy decisions, geopolitical developments and the ongoing evolution of artificial intelligence technologies. While these factors may contribute to periods of volatility, they also create opportunities for active investors with a long-term perspective.

The Board remains confident in the quality of the Company's portfolio, the experience of the investment team and our ability to identify attractive opportunities across the market. We will continue to apply our disciplined investment approach while maintaining a strong focus on capital preservation, shareholder returns and long-term value creation.

On behalf of the Board, I thank our shareholders for their continued support and confidence in Thorney Opportunities Limited.

ALEX WAISLITZ OAM B.EC, LLB,
NON-EXECUTIVE CHAIRMAN



Alex Waislitz was appointed Chairman of the Company on 21 November 2013.

Mr Waislitz is Chairman of Thorney Technologies Ltd and is the founder and Executive Chairman of the private Thorney Investment Group, one of Australia's most successful private investment groups. He has extensive business and capital markets experience and has been a member of several public company boards.

He is co-owner of the Australian Community Media group, Australia's largest regional media group which operates more than 160 regional publications across Australia.

Mr Waislitz was Vice President of the Collingwood Football Club Limited for more than 20 years, stepping down in 2021.

Mr Waislitz has established the Waislitz Foundation and the Waislitz Family Foundation charities, with the aim of donating \$50 million. These charities focus on community projects, education, health, indigenous programs and the arts.

In June 2023, Mr Waislitz was awarded a Medal (OAM) of the Order of Australia in the General Division for "service to the community through a range of organisations".

He is a graduate of Monash University in Law and Commerce and of the Harvard Business School OPM Program.

Mr Lanzer is Managing Partner of Arnold Bloch Leibler - a leading Australian commercial law firm - and has over 40 years' experience in providing legal and strategic advice to some of Australia's leading companies.

Mr Lanzer is also a Director of Premier Investments Limited, a Director of Just Group Limited and previously a Director of the TarraWarra Museum of Art. He is a Life Governor of the Mount Scopus College Council. In June 2015, Mr Lanzer was appointed as a Member of the Order of Australia.

Dr Weiss has considerable expertise in financial services businesses and extensive international business experience.

He holds several directorships including as Director of Ariadne Australia Limited (since November 1989), as Chairman of Coast Entertainment Holdings Limited (since September 2017), as Deputy Chairman of Myer Holdings Limited (a Director since November 2023.), as Director of Hearts & Minds Investments Limited, as a Director of Australian Athletics and Coaches Foundation Limited (March 2026), and as Chairman of Cromwell Property Group.

Dr Weiss is also a Commissioner of the Australian Rugby League Commission (since 2016). In June 2019 Dr Weiss was appointed as a Member of the Order of Australia.

During the past three years, Dr Weiss' also served as Chairman of Estia Health Ltd.

Peter Landos was appointed a Director of the Company on 31 March 2025.

Mr Landos is the Chief Operating Officer of the Thorney Investment Group and has extensive business and corporate experience specialising in advising boards and management in mergers and acquisitions, divestments, business restructurings and capital markets.

Mr Landos is a non-executive Director and Chairman of the Audit and Risk Committee of Gale Pacific Ltd and is also a member of the Company's Nomination Committee.

Mr Landos is also a non-executive Director of Adacel Technologies Limited, AnaeCo Limited and various entities within the 20 Cashews Pty Ltd group, including Rural Press Pty Ltd, View Media Group Pty Ltd and ViewJobs Pty Ltd.

Mr Landos was also appointed to the Board of the Western Bulldogs Football Club in December 2025.

Craig Smith CPA, ACIS was appointed secretary of the Company on 21 November 2013.

Mr Smith has been the Chief Financial Officer of the private Thorney Investment Group since 2008, was appointed company secretary of Thorney Technologies Ltd in 2016 and is a Director and company secretary of Anaeco Limited.

Prior to joining Thorney, Mr Smith held CFO / Company Secretarial roles with ASX listed companies Baxter Group Limited and Tolhurst Noall Limited.

3. Principal Activities

Thorney Opportunities Ltd is an investment company listed on the Australian Securities Exchange (ASX: TOP). Its principal activity is making investments in listed and unlisted securities.

There have been no changes in the nature of these activities during the 2026 financial year.

4. Result

The Company's loss before tax for the 2026 financial year was \$4,439,343, compared with a profit before tax of \$14,107,153 in 2025. Total comprehensive income for the year was \$857,511 (2025: \$8,541,057).

Net tangible assets after tax were 89.3 cents per share (2025: 90.3 cents per share).

5. Dividends

On 31 August 2026, the Board declared a final fully franked dividend of 1.65 cents per share (2025 final dividend: 1.55 cents per share). The dividend will be franked at a tax rate of 25% (2025: 30%). The Dividend Reinvestment Plan (DRP) will not operate in respect of the 2026 final dividend.

The Final dividend will be paid to shareholders on 30 September 2026. The total dividend of approximately \$2,768,116 has not been recorded as a liability in the financial accounts. The dividend will be paid to all shareholders who are duly recorded on the register of members as at 5pm on Friday, 11 September 2026.

The fully franked 2026 Interim dividend of 1.10 cents per share was paid on 31 March 2026.

The fully franked 2025 Final dividend of 1.55 cents per share was paid on 30 September 2025.

6. Review of Operations

For the financial year ended 30 June 2026, the Company's net tangible assets after tax per share decreased from 90.3 cents per share (cps) to 89.3 cps. This movement reflects loss in the value of the Company's listed equity investment portfolio, a decrease in the fair value of TOP's investment in 20 Cashews Pty Ltd (20C) and the impact of the ongoing share buy-back program.

TOP's five largest listed portfolio holdings Southern Cross Electrical Engineering Ltd (SXE), AMA Group Ltd (AMA), ZIP Co Ltd (ZIP), Solvar Ltd (SVR) and COG Financial Services Ltd (COG), represent approximately 49% of total assets.

Cash and cash equivalents as at 30 June 2026 were \$2,904,592 (2025: \$32,849,145). The net decrease predominantly reflects cash outflows from operating activities of \$19,275,063, payments for long-term investments of \$1,507,800, payments made in relation to the on-market buy-back totalling \$4,601,920, and dividends paid of \$4,559,770.

During the year 7,277,839 shares have been bought back at a total cost of \$4,601,920 with an average cost of 63.2 cents per share. (2025: 7,842,876 shares bought back for \$4,999,148, with an average cost of 63.74 cents per share).

During the year the Company lodged change of interest of substantial holder notices for AMA Group Ltd (AMA), Earlypay Ltd (EPY), Quickfee Ltd (QFE), Service Stream Ltd (SSM), Hub24 Ltd (HUB) and COG Financial Services Ltd (COG), became a substantial holder for Retail Food Group Ltd (RFG) and Spirit Technology Solutions Ltd (ST1), and ceased to be a substantial holder for Service Stream Ltd (SSM).

7. Financial Position

8. Prospects

The Company remains committed to maintaining its disciplined approach to investing.

The Board is optimistic that, in this challenging economic environment, opportunities which may be attractive to the Company will continue to emerge over the coming period.

9. Material Business Risks

The material business risks that have been identified for the Company are investment risk and operational risk. With an investment mandate that has exposures to small and medium size capitalisation companies, TOP will always bear market risk as it invests its capital in assets that are not risk free. Investment risk covers investment strategy, leverage, investment manager, market price, collateral, credit, counterparties, liquidity, unlisted early stage and small cap businesses, portfolio turnover, derivatives, diversification, foreign currency, outsourcing, interest rates and the regulatory environment. Operational risks include key person risk, regulatory risk and cyber security risk.

Our risk management framework, which is overseen by our Audit & Risk Committee, has been designed to monitor, review and continually improve risk management at the Company.

10. Events Subsequent to Balance Date

Since the end of the year, the Directors declared a final fully franked dividend of 1.65 cents per share, to be paid on 30 September 2026.

11. 2026 Remuneration Report (Audited)

This report outlines the Key Management Personnel (KMP) remuneration arrangements of the Company in accordance with the requirements of the *Corporations Act 2001* and its Regulations.

For the purposes of the report, KMP are defined as those persons and corporate entities having authority and responsibility for planning, directing and controlling activities of the Company.

For Thorney Opportunities Ltd the KMP are the non-executive Directors and the Investment Manager.

(a) Remuneration of Directors

The non-executive Directors are remunerated by the Company. It is the policy of the Board to remunerate Directors at market rates commensurate with the responsibilities undertaken by non-executive Directors. The remuneration of the non-executive Directors is not linked to the performance of the Company.

NON-EXECUTIVE DIRECTORS' FEES

The non-executive Directors' base remuneration is reviewed annually. The amount of base remuneration is not dependent on the satisfaction of a performance condition, or on the performance of the Company, the Company's share price, or dividends paid by the Company.

NON-EXECUTIVE CHAIRMAN'S FEES

For his role as Chairman and director of TOP, the non-executive Chairman, Alex Waislitz, receives zero directors' fees and zero retirement benefits.

RETIREMENT BENEFITS FOR DIRECTORS

The Company does not provide retirement benefits (other than superannuation) to the non-executive Directors. The Investment Manager does not provide retirement benefits (other than superannuation) to the non-executive Chairman.

OTHER BENEFITS (INCLUDING TERMINATION) AND INCENTIVES

The Company does not pay other benefits and incentives to the non-executive Directors. The Company and the Investment Manager do not pay other benefits and incentives to the non-executive Chairman.

(b) Remuneration of the Investment Manager

Thorney Management Services Pty Ltd (TMS, the Investment Manager), is a corporate entity controlled by Mr Waislitz that has specified authority and responsibility in regard to the management of the Company's investment portfolio and is remunerated by the Company in accordance with the Investment Management Agreement (IMA). In February 2023, the IMA was extended for a further 7 years expiring 21 November 2030.

In respect of the year ended 30 June 2026, the Investment Manager was entitled to:

- a base fee of \$2,669,111 net of claimable GST and RITC (2025: \$2,687,697), being a base fee equal to 0.75% per half year of the gross asset value of the Company, payable half-yearly in arrears, calculated as at the last business day of the relevant half-year; and
- a performance fee of \$221,119 net of claimable GST and RITC (2025: \$2,202,411). The fee is the greater of zero and the amount calculated as 20% of the Increase Amount. The Increase Amount is the adjusted Increased Net Asset Value for the current period less the High Water Mark and less a hurdle, equivalent to the value of any Base Fee paid or accrued since the High Water Mark Base Financial Year. Performance fee entitlements are calculated on an annual basis, commencing on 1 July of each financial year. If there is no Increase Amount for a financial year, no performance fee is payable.
- Base fees and performance fees are calculated in accordance with the IMA.

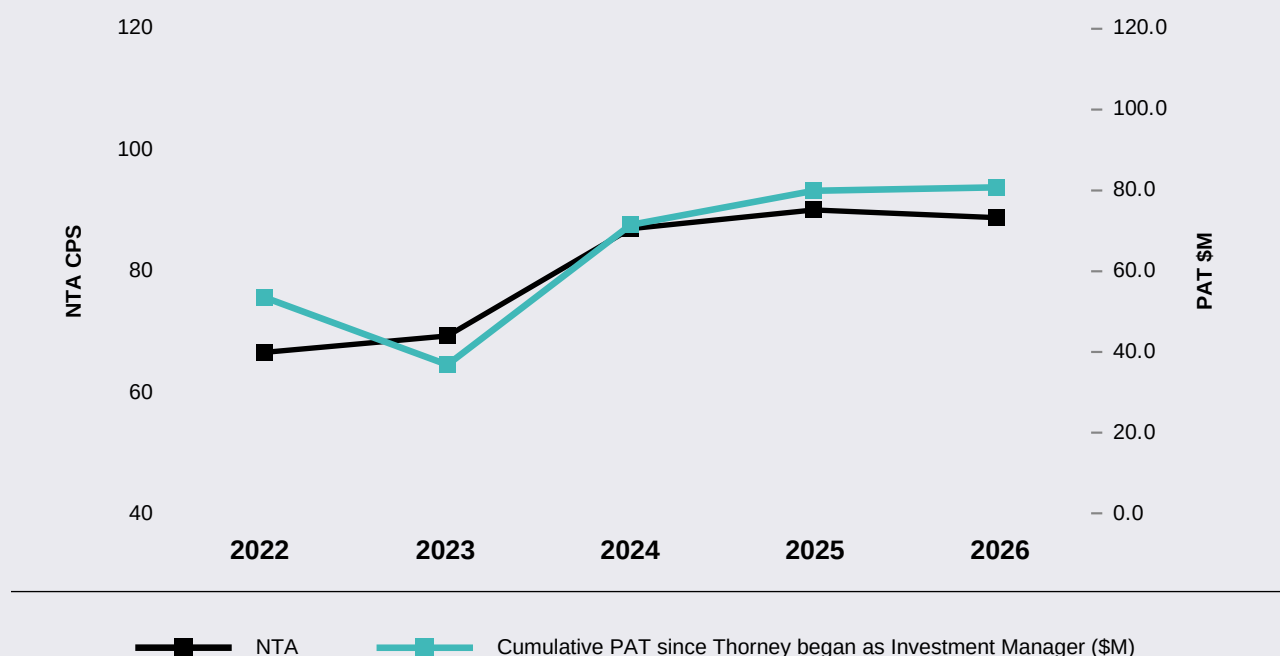

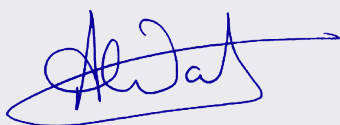

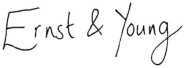

Notes to the Financial Statements

1. Corporate information

The financial statements of Thorney Opportunities Ltd and its subsidiary (collectively TOP or the Company) for the year ended 30 June 2026 were authorised for issue in accordance with a resolution of the directors on 31 August 2026. The directors have the power to amend and reissue the financial report.

Thorney Opportunities Ltd is a Company limited by shares, incorporated and domiciled in Australia.

The nature of the operations and principal activities of the Company are described in the director's report.

The Company's investment activities are managed by Thorney Management Services Pty Ltd pursuant to an Investment Management Agreement (IMA) approved by shareholders.

2.1 Summary of material accounting policies

(a) Basis of preparation

The financial statements are general purpose financial statements that have been prepared in accordance with the requirements of the *Corporations Act 2001*, Australian Accounting Standards and other authoritative pronouncements of the Accounting Standards Board. The financial statements are presented in Australian Dollars, and the Company is a for-profit entity for the purpose of preparing financial statements.

The annual report has also been prepared on a historical cost basis, except for financial assets and financial liabilities held at fair value through profit or loss, that have been measured at fair value.

Statement of compliance

The financial statements have been prepared in accordance with the Australian Accounting Standards as issued by the Australian Accounting Standards Board and International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board.

Changes in Accounting Standards

None of the standards, interpretations or amendments to existing standards that are effective for the first time for the financial year beginning 1 July 2025 have a material impact on the amounts recognised in the prior periods or will affect the current or future periods.

Standards issued that might have an impact but not yet effective

AASB 18 *Presentation and Disclosure in Financial Statements*, is applicable to the Company from 1 July 2027. AASB 18 introduces new requirements on presentation within the statement of profit or loss, including specified totals and subtotals. It also requires disclosure of management-defined performance measures and includes new requirements for aggregation and disaggregation of financial information based on the identified 'roles' of the primary financial statements and the notes. The Company has not yet completed its assessment of the impact of this new standard on the Financial Report.

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 July 2026 and have not been early adopted in preparing these financial statements.

None of these are expected to have a material effect on the financial statements of the Company.

2.1 Summary of material accounting policies continued

(b) Basis of consolidation

The Company meets the definition of an Investment Entity under AASB 10 *Consolidated Financial Statements*, as it meets the following criteria:

- the Company obtains funds from shareholders for the purpose of providing them with investment management services;
- the Company's business purpose, which it communicated directly to shareholders, is investing solely for returns from capital appreciation and investment income; and
- the performance of investments made by the Company are measured and evaluated on a fair value basis.

The Company meets all the typical requirements of an investment entity.

The Company has determined that for any entities it controls or has significant influence over, that do not provide investment related services to the Company, consolidated financial statements are not required. The Company's investments in these entities are measured at fair value through profit and loss in accordance with AASB 9 *Financial Instruments*.

Disclosure of subsidiaries and their country of tax residency as required by the *Corporations Act 2001* does not apply to the company as it is not required by accounting standards to prepare consolidated financial statements.

2.2 Accounting judgements and estimates

The preparation of the Company's financial statements requires management to make judgements, estimates and assumptions that affect the amounts recognised in the financial statements. However, uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amount of the asset or liability affected in the future.

The significant accounting policies have been consistently applied in the current financial year and the comparative period, unless otherwise stated. Where necessary comparative information has been re-presented to be consistent with current period disclosures.

Fair value of financial instruments

When the fair values of financial assets and financial liabilities recorded in the statement of financial position cannot be measured based on quoted prices in active markets, their fair value is measured using valuation techniques, such as recent transaction prices in the private market or discounted cash flow models. The inputs to these models are taken from observable markets where possible, but where this is not feasible, a degree of judgement is required in establishing fair values. Judgements can include considerations of discount rate, growth rate, forecasted cashflows and other inputs such as liquidity risk, credit risk and volatility. Changes in assumptions about these factors could significantly affect the estimated reported fair value of financial instruments. Further details are provided in 'Note 8 - Key inputs and sensitivities'.

Taxes

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits, together with future tax planning strategies. Further details are provided in Note 4.

Notes to the Financial Statements

2.3 Summary of material accounting policy information

The material accounting policies applied in the preparation of these financial statements are set out below.

a) Financial instruments

(i) Classification

The Company classifies its financial assets and financial liabilities into the categories below in accordance with AASB 9.

Financial assets and liabilities at fair value through profit or loss

The Company manages two discrete portfolios of financial instruments: the long-term portfolio and the trading portfolio.

The long-term portfolio comprises securities that the Directors intend to retain over the long term, principally to generate capital appreciation. These investments are presented as non-current financial assets in the statement of financial position.

The trading portfolio comprises securities and derivatives acquired or entered into principally to generate a profit from short-term price movements. Trading financial assets are presented as current assets, while any trading financial liabilities, including derivative liabilities, are presented as current liabilities in the statement of financial position. All derivatives are classified as held for trading.

Other financial liabilities

This category includes all financial liabilities, other than those classified as at fair value through profit or loss. Other financial liabilities are measured at amortised cost. Amounts are generally settled within 30 days of being recognised as other financial liabilities. Given the short-term nature of other financial liabilities, the carrying amount approximates fair value.

(ii) Recognition

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

Purchases or sales of financial assets that require delivery of assets within the time frame generally established by regulation or convention in the marketplace are recognised on the trade date, i.e. the date that the Company commits to purchase or sell the asset.

The Company includes in this category equity instruments. Equity instruments include investments in subsidiaries and associates. The following is noted:

- *Investment in subsidiaries:* in accordance with the exemption under AASB 10 *Consolidated Financial Statements*, investments in subsidiaries are not consolidated, unless the subsidiary does not meet this exemption because it performs services that relate to the investment activity of the Company. Otherwise the Company measures unconsolidated subsidiaries at fair value through profit and loss.
- *Investment in associates:* in accordance with the exemption in AASB 128 *Investment in Associates and Joint Ventures*, the Company does not account for its investments in associates using the equity method. Instead the Company measures its investments in associates through fair value through profit and loss.

iii) De-recognition

A financial asset (or, where applicable a part of a financial asset or part of a group of similar financial assets) is derecognised where:

- i. The rights to receive cash flows from the asset have expired; or
- ii. The Company has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement; and
- iii. Either (a) the Company has transferred substantially all the risks and rewards of the asset, or (b) the Company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

The Company derecognises a financial liability when the obligation under the liability is discharged, cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of comprehensive income.

2.3 Summary of material accounting policy information continued

a) Financial instruments continued

(iv) Initial measurement

Both the long-term and trading portfolios are classified at initial recognition as financial assets at fair value through profit or loss. All transaction costs for such instruments are recognised directly in profit or loss.

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value presented in the statement of profit or loss.

Loans and receivables and financial liabilities (other than those classified as at fair value through profit or loss) are measured initially at their fair value plus directly attributable transaction costs, in the case of loans and receivables, and net of directly attributable transaction costs for financial liabilities.

When the transaction price of the instrument differs from the fair value at origination and the fair value is based on a valuation technique using only inputs observable in market transactions, the Company recognises the difference between the transaction price and fair value in net trading income. In those cases where fair value is based on models for which some of the inputs are not observable, the difference between the transaction price and the fair value is deferred and is only recognised in profit or loss when the inputs become observable, or when the instrument is derecognised.

Dividend income earned on investments held at fair value through profit or loss is recognised separately in the statement of comprehensive income.

(v) Subsequent measurement

After initial measurement, the Company remeasures financial instruments which are classified as at fair value through profit or loss at fair value (see note 8). Subsequent changes in the fair value of those financial instruments are recorded in 'Change in fair value of financial assets and liabilities at fair value through profit or loss'. Interest earned is recorded in 'Interest revenue' according to the terms of the contract. Dividend revenue is recorded in 'Dividend revenue'.

b) Fair value measurement

The Company measures financial assets and liabilities at fair value through profit or loss, such as equity securities and debt instruments, at each balance sheet date.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- In the principal market for the asset or liability, or
- In the absence of a principal market, in the most advantageous market for the asset or liability

The principal or most advantageous market must be accessible to the Company.

The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1	Quoted (unadjusted) market prices in active markets for identical assets or liabilities
Level 2	Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable
Level 3	Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

c) Functional and presentation currency

The Company's functional and presentation currency is the Australian Dollar, which is the currency of the primary economic environment in which it operates. The Company's performance is evaluated and its liquidity is managed in Australian Dollars. Therefore, the Australian Dollar is considered as the currency that most faithfully represents the economic effects of the underlying transactions, events and conditions.

Notes to the Financial Statements

2.3 Summary of material accounting policy information continued

d) Interest revenue and expense

Interest earned on financial assets classified as 'at fair value through the profit or loss' is recorded in 'Interest revenue' according to the terms of the contract. Interest income from financial assets at amortised cost is recognised using the effective interest method and includes interest from cash and cash equivalents. The effective interest method is a method of calculating the amortised cost of a financial asset and of allocating the interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments or receipts throughout the expected life of the financial instrument, or a shorter period where appropriate, to the net carrying amount of the financial asset. When calculating the effective interest rate, the Company estimates cash flows considering all contractual terms of the financial instruments (for example, prepayment options) but does not consider future credit losses. The calculation includes all fees paid or received between the parties to the contract that are an integral part of the effective interest rate, including transaction costs and all other premiums or discounts.

e) Dividend revenue

Dividend revenue is recognised when the Company's right to receive payment is established.

f) Fees, commissions and other expenses

Except where included in the effective interest calculation (for financial instruments carried at amortised cost), fees and commissions are recognised on an accrual basis. Legal and audit fees are included within 'Legal and professional fees' and are recorded on an accrual basis.

g) Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash on hand, demand deposits, short term deposits in banks with original maturities of three months or less and short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

For the purpose of the statement of cash flows, cash and cash equivalents is presented as defined above, net of outstanding bank overdrafts.

h) Margin account

The Company maintains a margin cash account with UBS, which is adjusted daily based on the collateral requirements for its open derivative positions. The margin account is used to meet collateral requirements associated with the Company's derivative trading activities.

i) Taxes

Current income tax

Current income tax assets and liabilities for the current period are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date where the Company operates and generates taxable income.

Current income tax relating to items recognised directly in equity is recognised in equity and not in the statement of profit or loss. Management periodically evaluates positions taken in the tax returns with respect to situations in which applicable tax regulations are subject to interpretation and establishes provisions where appropriate.

Deferred tax

Deferred tax is provided using the liability method on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- i. When the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss
- ii. In respect of taxable temporary differences associated with investments in subsidiaries, associates and interests in joint arrangements, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date.

j) Profits reserve

The profits reserve is made up of amounts transferred from current and retained earnings that are preserved for future dividend payments.

2.3 Summary of material accounting policy information continued

k) Due to and due from brokers

Amounts due to brokers are payables for securities purchased (in a regular way transaction) that have been contracted for but not yet delivered on the reporting date. *Refer to the accounting policy for 'other financial liabilities' for recognition and measurement of these amounts.*

Amounts due from brokers include margin accounts and receivables for securities sold (in a regular way transaction) that have been contracted for but not yet delivered on the reporting date. *Refer to accounting policy for 'loans and receivables' for recognition and measurement of these amounts.*

l) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of GST except:

- i. When the GST incurred on a purchase of goods and services is not recoverable from the taxation authority, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item as applicable; and
- ii. Receivables and payables are stated with the amount of GST included.

Reduced input tax credits (RITC) recoverable by the Company from the ATO are recognised as a receivable in the Statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the taxation authority, is classified as part of operating cash flows.

Listed investments trading in an active market are valued based upon quoted market prices at each balance sheet date. A market is regarded as active if quoted prices are readily and regularly available from an exchange, dealer, broker, industry group, pricing service, or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis. The fair value of listed equities that are actively trading in an active market at 30 June 2026 are classified as Level 1.

Deposits with unlisted trusts are valued based on the expected future contractual cash flow and market discount rate.

Unlisted financial assets (long term financial assets) are valued at fair value in accordance with AASB 13 *Fair Value Measurement*, applying the principles in '*International Private Equity and Venture Capital Valuation Guidelines*'. Valuation of Level 3 financial instruments

The responsibility for the valuation of unlisted equity and debt instruments is delegated by the Board of the Company to the investment sub-committee. Investment valuations are reviewed on a regular basis and reviewed by the investment sub-committee.

Investments with a recent transaction: Recent investment

The recent third-party transaction price methodology uses the price established in a significant arm's length transaction involving the investee's securities. The Investment Manager assesses whether the transaction price remains representative of fair value by considering the size and nature of the transaction, the parties involved, the time elapsed since the transaction, and any subsequent events or changes in circumstances affecting the investee.

Pre-revenue investments: Milestone approach

When a recent transaction has not occurred and an investment is in the early stages of its business and is not yet generating sufficient revenue, earnings and/or cash flows, a Milestone Approach is used to determine the investment's fair value. Under this method, the investment's progress is regularly assessed against strategic milestones set by the investee. The investment's fair value determination takes into account the best information available, including company and shareholder updates, as well as readily available market participant data and assumptions.

For loan notes classified as Level 3, cost is generally considered to approximate fair value where there has been no significant change in the credit risk, terms or expected recoverability of the instrument since initial recognition. The value of loan notes and unlisted equities classified as Level 3 may increase or decrease depending on the success of start-up operations and capital raisings. 17. Financial risk management

The Company's objective in managing risk is the creation and protection of shareholder value. Risk is inherent in the Company's activities, but it is managed through a process of ongoing identification, measurement and monitoring, subject to risk limits and other controls. The process of risk management is critical to the Company's continuing profitability. The Company is exposed to credit risk, liquidity risk and market risk (which includes interest rate risk and equity price risk) arising from the financial instruments it holds.

Credit risk

Credit risk is the risk that the counterparty to a financial instrument will cause a financial loss for the Company by failing to discharge an obligation.

The Company is exposed to the risk of credit-related losses that can occur as a result of a counterparty or issuer being unable or unwilling to honour its contractual obligations. These credit exposures exist within financing relationships, derivatives and other transactions.

It is the Company's policy to enter into financial instruments with reputable counterparties. The Investment Manager closely monitors the creditworthiness of the Company's counterparties (e.g. brokers, custodian, banks etc.) by reviewing their credit ratings, financial statements and press releases on a regular basis.

Liquidity risk

Liquidity risk is defined as the risk that the Company will encounter difficulty in meeting obligations associated with financial liabilities. Liquidity risk arises because of the possibility that the Company could be required to pay its liabilities earlier than expected.

The Company invests primarily in marketable securities and other financial instruments that, under normal market conditions, are readily convertible to cash. Other unlisted investments, excluding the deposit with the unlisted trust, represent approximately 12% (2025: 17%) of total investments. Realising the Company's investment in its largest unlisted investment, 20 Cashews Pty Ltd, may require a significant transaction and could involve a longer lead time.

In addition, the Company has no borrowings and has a daily policy to monitor and maintain sufficient cash and cash equivalents to meet normal operating requirements.

Market risk

Market risk is the risk that the fair value or future cash flows of financial instruments will fluctuate due to changes in market variables such as interest rates and equity prices. As the Company is a listed investment company with a flexible investment mandate, the Company will always be subject to market risks as the prices of its investments fluctuate with the market.

The Company's listed and unlisted equity securities are susceptible to market price risk arising from uncertainties about future values of the investments. The Company manages the equity price risk through adherence to its investment policy and objectives.

At the reporting date, the exposure to listed and unlisted securities at fair value was \$158,838,287 (2025: \$143,676,252). A decrease of 10% in share value of securities held could have an impact of approximately \$15,883,829 (2025: \$14,367,625) on the income or equity attributable to the Company. An increase in 10% in share value of securities held would have a similar favourable impact on income and equity.

Interest risk

Interest rate risk arises from the possibility that changes in interest rates will affect future interest income. The Company's exposure to interest rate risk relates primarily to cash at bank, short-term deposits, unlisted convertible loan notes and investments in unlisted unit trusts that earn interest or provide returns linked to variable interest rates. A change in interest rates of 1% at balance date would have an impact on net profit or loss of approximately \$130,000, assuming all other variables remain constant.

The Company entered into an investment management agreement (IMA) with TMS for an initial period of 10 years expiring 21 November 2023. The IMA has been extended for a further 7 years to 21 November 2030.

Under this agreement TMS is entitled to a base fee and a performance fee. For the year ending 30 June 2026 a base fee of \$2,669,111 (2025: \$2,687,697) and a performance fee of \$221,119 (2025: \$2,202,411) was paid or payable to TMS. The Company must pay TMS within 60 days of receiving an invoice. Amounts are net of claimable GST and RITC. As at 30 June 2026, the management fee payable is \$1,254,331 (2025: \$1,390,631) and the performance fee payable is \$221,119 (2025: \$2,202,411).

TIGA Trading Pty Ltd, a related entity of TMS, employs personnel to provide company secretarial and financial accounts preparation services to Thorney Opportunities Ltd. These services are provided on commercial terms and total \$70,000 for the 2026 financial year (2025: \$70,000).

TMS, TIGA Trading Pty Ltd, Thorney Holdings Pty Ltd and Thorney Investment Group Australia Pty Ltd are related bodies corporate controlled by Alex Waislitz by virtue of 608(1) of the *Corporations Act (2001)*.

The Company may co-invest in financial assets alongside entities associated with Mr Alex Waislitz, including Thorney Investment Group and certain private entities controlled by him. The Company's listed investments are held directly. For the purposes of the substantial holding provisions of the *Corporations Act 2001*, these entities may be associates of the Company by virtue of their common control by Mr Alex Waislitz. Where the aggregated relevant interests of the Company and its associates exceed 5% of the voting shares in a listed investee entity, the Company lodges a substantial holder notice with ASX in accordance with section 671B of the *Corporations Act 2001*.

While the Investment Manager maintains a primary buy/hold/sell strategy for each managed investee company, from time to time an investee company may, for commercial reasons such as cash flow or tax management, execute a trade with a divergent view. To mitigate any actual, perceived or potential conflicts of interest, the Investment Manager maintains a register which is regularly presented to the Board via compliance reports.

During the year, the Company engaged Arnold Bloch Leibler, a legal firm of which Henry Lanzer is the Managing Partner, to provide legal advice totalling \$1,891 (2025: \$1,215). In accordance with the terms of Mr Lanzer's appointment, a payment of \$56,000 was paid or payable to Arnold Bloch Leibler as remuneration for his role as a Director of the Company (2025: \$55,750).

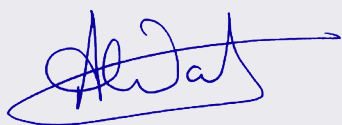

As outlined in Note 8 to the financial report, these investments are carried at fair value through profit and loss in accordance with the requirements of Australian Accounting Standards. For listed equities fair value is assessed based on quoted prices in active markets at reporting date. For unlisted investments, the Company prepares a valuation of the unlisted investment holdings using valuation methodologies that include a discounted cash flow model or by reference to the most recent transactions price. The assumptions used in the discounted cash flow model and appropriateness of the most recent transaction price require significant judgement as there are significant unobservable market inputs used in the valuation. Accordingly, the valuation and existence of listed and unlisted investments were considered a key audit matter due to the size of the investment portfolio and the significant judgement involved in valuing the unlisted investments. For the year ended 30 June 2026, management fees were \$2.67 million, and performance fees were \$0.22 million, which represented 73% and 6% of the total expenses respectively as disclosed in Note 18. Management fees and performance fees paid to the Investment Manager, Thorney Management Services Pty Ltd (TMS), are the most significant operating expenses for the Company. In accordance with the Investment Management Agreement (IMA), TMS is entitled to a management fee of 0.75% of gross assets. The base management fee is calculated half yearly. Performance fees are recognised in the financial report if the performance hurdles for the Company have been met at the end of the relevant measurement period, which is the date that the performance criteria is met and the obligation has crystallised. In accordance with the IMA, performance fees are calculated on an annual basis as 20% of the increase in net asset value, net of base management fee for the year. All expenses are recognised on an accrual basis. The assessment of the recognition of expenses relating to performance fee arrangements can be complex and are paid to a related party. Accordingly, this was considered a key audit matter.
